Dear Oswego County Legislators,

“Oswego County government is committed to visionary leadership that will enhance the quality of life for its people and businesses. Leadership shall promote open communication and accountability between government and residents, effective, and affordable services, an environment conducive to economic development, and the effective use and conservation of our natural, financial, and human resources.”

Keeping in mind your mission statement I would like to express some of the concerns your citizens have regarding this virus and the handling of the situation.

Whether you believe that covid-19 is a natural virus or it was manipulated by Dr. Anthony Fauci using the gain of function method (funded by millions of our tax dollars) which makes a virus more deadly and contagious, and then the study was transferred to Wuhan China; or it was released intentionally or unintentionally from a lab in Wuhan China financed by the NIH (National Institutes of Health) which Anthony Fauci is the director; no matter what your belief of it's origin, covid-19 has devastated our world. Not just NYS, not just the United States, but the world.

It is evident to see by the many studies and *reports being **withdrawn, retracted (a very rare move in science according to Dr. Judy Mikovits), and/or buried*** regarding covid , masks usefulness, and the vaccines; that these reports are worth considering. It's like something is being hidden from us.

Now during this time our civil rights have been taken away, we've been mandated to wear face coverings and social distance. We've lost our businesses that weren't

categorized as “essential” losing our livelihoods, people are scared and our children are being forced to go to school wearing a mask to study and to play. We have been denied the right to be with loved ones that are sick or dying in the hospital and we can’t even have a proper funeral for them. We have lost our God given rights of freedom and if that wasn’t enough now we are being bombarded by propaganda and coercion to get an **EXPERIMENTAL** “vaccine”.

The so called coronavirus has been deadly for some, but not in “*panic-pandemic*” proportions which we have been led to believe. Although it has spread all over the world we are seeing statistics that are telling us it is not as deadly as purported. Most health statistic websites are stating that there is a 99% survival rate while the Worldometer is showing a 98% survival rate. Many of the statistics tell us this is another virus; one of many that we have dealt with, nothing to cause panic. As many flues are dangerous to people with weakened immune systems this is a virus that will possibly threaten them as does the annual flu every year.

With the **survival rate being between 98-99%** these measures of “protection”; masks, social distancing, testing and an experimental shot are not necessary. It takes only common sense to see this.

As of 2019 the population of Oswego county was 117,571. There were 90 covid **related** deaths making it a less .076% of the population whom succumbed to covid between the dates of March of 2020 to May 10, 2021 (14 months). As of today the survival rate is **99.7%** for those who were diagnosed since March of 2020.

Although there is much evidence that masks do not work and are unhealthy for us to wear we are still mandated to wear them. We are still upholding the belief that we need masks to stop the spread of the virus while walking to our table in a restaurant and then when seated can remove the masks and interact with the waitstaff without fear of spreading the virus. These mask mandates are ludicrous! I have shared some supporting links to this evidence below.

As for the testing for the virus, it has been done primarily using the PCR test. According to the Cleveland Clinic in Ohio, “The PCR test is the “gold standard” test for diagnosing Covid-19 because it’s the most accurate and reliable test.” **This could not be further from the truth.**

According to **Kary Mullis** who happened to **invent the PCR test** and who was awarded the Nobel Peace Prize in 1993 in chemistry for **inventing the PCR test**, quote-“the PCR **should never be used as a tool in the diagnosis of infectious diseases.**” The PCR was designed for a broad variety of applications including biomedical research and criminal forensics. A true rebel against Big Pharma and the CDC, **Mullis insisted that it states on the box of every PCR test: “This is not a diagnostic tool.”** See attached.

The PCR test is so well known for giving **inaccurate results** that the CDC warns not to give the test to asymptomatic persons “because of the increased likelihood of false-positive results.” The more false-positives, the more inaccurate reporting of covid infections, and the more fear can be perpetuated.

The FDA has issued an EUA (emergency use authorization) for the covid “vaccines”. The recipients **MUST** be informed of the ingredients, risks and possible benefits and that they have the option to accept or refuse the vaccine. Now look back at the survival statistics...**98-99% survival rate**— — this experimental vaccine is not needed! It is purported by the vaccine manufacturers that the “vaccines” can possibly lessen the side effects; **not prevent you from getting or spreading the virus**. Also, the vaccine companies are **not liable** for injuries or deaths caused by their vaccines!!

As for vaccine injuries or deaths; there have been many reported to VAERS (Vaccine Adverse Event Reporting System) which is not totally conclusive granted not everyone with adverse effects thinks or even knows about reporting them.

The following is a quote from the VAERS website:

- “The number of reports alone cannot be interpreted or used to reach conclusions about the existence, severity, frequency, or rates of problems associated with vaccines.”

By the way; **VAERS** is co-sponsored by the Centers for Disease Control and Prevention (CDC), and the Food and Drug Administration (FDA), agencies of the U.S. Department of Health and Human Services (HHS). **AKA a conflict of interest.**

If you do research regarding the adverse effects and deaths from these “vaccines” I believe you will become greatly alarmed by seeing the numbers. **This experiment needs to stop!**

Which Companies Received The Most Covid-19 Vaccine R&D Funding?

“The United States and Germany have been the largest investors in Covid-19 vaccine R&D, pouring approximately \$2 billion and \$1.5 billion into the effort, respectively. Notably, out of \$5.9 billion in investment tracked up to March 2021, 98.12% was public funding. The money primarily went to private companies with both Moderna and Janssen receiving more than \$900 million. Pfizer PFE **-0.3%** and BioNTech, who developed the first Covid-19 vaccine authorized in the United States, received some \$800 million in R&D funding. Practically all of the money invested in the three companies came from public funding.”

You should also know that while some insurance companies are paying for the administering of this “vaccine”; **your tax dollars** are paying these drug companies for each shot of their **experimental** vaccine, so they are essentially taking no risks and have no liabilities!
